ORDER

Vide paper read as (1) above, the Vice Chancellor has accorded sanction for enhancement in the existing fees / charges for the various services rendered by the University of Calicut by 5% with effect from 01/06/2023 and also issued directions to all the Heads of Teaching Departments/ Branches/ University Centres to issue necessary orders in this regard. Enhancement will be a 5% increase in the existing rate and if the increased rate is not a multiple of ₹ 5/-, the revised fee / charge will be fixed to the next highest multiple of ₹ 5/-.

Considering the matter in detail, the Vice Chancellor, vide paper read as (2) above has approved the increase of all fees/charges by 5% with effect from 01/06/2023 in respect of the Department of Students' Welfare, as shown in the table.
